WAMT Qualification system based on the participation in the National Championship for the European Championship 2026.

Terms and conditions

National federation that has qualification system is obligated to have all disciplines and age categories that are a part of the WAMT Rulebook for the season in the final round of the national championship. There cannot be any sort of merging disciplines and age categories. In twirling disciplines competitors may qualify in lower and upper level. This also means that there can be only one level in majorette disciplines and two levels in twirling disciplines. Age categories must be calculated by the reference date which is June 30th 2026, for the entire season beginning with September 1st 2025. Judging and scoring system on all levels of national championship must be according to WAMT and done only by judges with WAMT national or international licence. All judges must have valid judges ID card, signed the WAMT Judges Codex and paid the annual judges' fee. National championship cannot offer disciplines and age categories which do not exist in WAMT Competition rulebook. If there is a provisional discipline published by WAMT for the season, the national association must implement it on the national level. National federation that is qualifying choreographies to the WAMT competitions is not allowed to qualify any choreography for any other competition that is not part of WAMT Official calendar. WAMT Polska, as the National federation that is qualifying choreographies to the WAMT competitions, cannot cooperate with any other national or international association in order to organize competitions together that nominate participants to other federations than WAMT.

Qualifications for the European Championship 2026 for each category are determined upon the participation in the National Championship. The team is required to participate in the national championship in order to be eligible to compete in the ECH 2026. Only the choreographies that were performed in the National Championship are allowed to be registered for the European Championship 2026. Teams cannot register any additional choreography to the European Championship that was not performed on the National Championship.

Only qualified choreographies can start in the ECH. If a qualified team will not start in the ECH regardless of the reason there cannot be given any additional qualifications to other teams.

National association must officially send to WAMT the complete result list of the final round of the national championship with visible qualifications and scores within 7 days of end of the final round of the national championship but before the deadline for the National Nominations to ECH. If the 7 days period oversteps the deadline for the National Nominations to ECH, the deadline for the National Nominations to ECH will be determined as the final day to provide documents to WAMT. The deadline for the National Nominations to ECH is April 27th 2025.

By signing this document, WAMT Polska becomes the only official WAMT ambassador for Poland and all competitors and members from Poland must qualify through the WAMT Polska in order to participate in the WAMT European Championship 2026.

WAMT will publish the qualification terms and conditions for the Polish participants on the official website.

The contract is valid from the date of signing until the September 1st 2026.
